

IN A TAX-DEFERRED ANNUITY...

YOU PAY NO TAXES ON YOUR INTEREST UNTIL IT'S WITHDRAWN.

IN CD'S & SAVINGS ACCOUNTS, INTEREST IS TAXED WHETHER IT'S LEFT TO ACCUMULATE OR WITHDRAWN.

TAX-DEFERRAL CAN SIGNIFICANTLY EFFECT THE GROWTH POTENTIAL OF YOUR NEST EGG. THE FOLLOWING TABLE SHOWS WHAT PRE-TAX INTEREST RATE MUST BE EARNED BY A TAXABLE ACCOUNT TO EQUAL THE SAME TAX-DEFERRED RATE OF AN ANNUITY, ASSUMING NO CURRENT DISTRIBUTION. FOR EXAMPLE, **SOMEONE IN A 38.80% TAX BRACKET WOULD HAVE TO EARN 6.54% INTEREST IN A TAXABLE ACCOUNT CD ETC.... TO MATCH THE ANNUITY TAX-DEFERRED RATE OF 4.00%.**
